

# POLICY FOR COMPLETION OF THE PGA PLAYING STANDARD FOR REMOTE TRAINEES

Published 31/1/2019

The following outlines the criteria under which a *Remote Trainee* is permitted to complete the PGA Playing Standard via modified conditions in relation to the number of Academy Approved Rounds in each Playing Stage.

## 1. Coverage

This policy will only be applied to Trainees attempting the PGA Playing Standard as per PGA Membership Regulation 7.7.1(a)ii)

#### 2. Remote Trainee

- a. A Remote Trainee is defined as a Trainee or Provisional Member (completing the PGA Playing Standard) residing a minimum of 300 kilometres from their nearest state capital city, via the most direct road-based route.
- b. The PGA Academy will make the final decision on the most direct road-based route.

## 3. Application

- a. To access the conditions provided to Remote Trainees in relation to the PGA Playing Standard, Trainees must complete the application form provided by the PGA Academy by the date indicated.
- b. Failure to complete the form by the date indicated will result in Trainees being required to complete the full PGA Playing Standard in that Trainee Playing Period.

### 4. PGA Membership Regulation 7.7.1(a)ii)

Following successful application to access the conditions provided to Remote Trainees, PGA Membership Regulation 7.7.1(a)ii) will be applied as follows:

- 1 Playing Stage of a minimum of 15 rounds under Academy approved conditions (as designated by the Academy) and 15 rounds accompanied by a Full Member (Vocational) of the PGA within one Trainee Playing Period, as designated by the Academy.

### 5. PGA Membership Regulation 7.7.1(a)iii)

Following successful application to access the conditions provided to Remote Trainees, PGA Membership Regulation 7.7.1(a)iii) will be applied as follows:

- Following successful completion of the PGA Playing Standard as outlined in clauses 7.7.1(a)(ii), a Remote Trainee is required to play in a minimum of ten (10) rounds under Academy approved conditions and 10 rounds accompanied by a Full Member (Vocational) of the PGA in each Trainee Playing Period (as designated annually by the Academy).

## 6. Trainee Playing Logbook

As per clauses 4 and 5 of this policy, as directed by the PGA Academy, Remote Trainees will be required to submit a playing logbook in relation to rounds playing with a Full Member (Vocational) of the PGA.

## 7. Trainee Playing Invites

Remote Trainees completing the PGA Playing Standard via modified PGA Membership Regulations 7.7.1(a)ii) and 7.7.1(a)iii) remain eligible for Trainee Playing Invites, Titleist-FootJoy Performance Rankings, Trainee Order of Merits and other awards, provided minimum round requirements are met for each applicable invite, ranking, etc. (50% of standard rounds).

### 8. Provisional Members

The conditions outlined in this policy may be accessed by Provisional Members completing the PGA Playing Standard via PGA Membership Regulation 7.7.1(a)ii).
